PHYSICAL LOCATION

Compilation of information from potential host Governments

1. The conclusions of the Contact Group on the topic of the physical location of the permanent secretariat, as contained in the report of the Committee on its tenth session, were as follows (A/AC.237/76, para. 123 (d)):

"(d) The Contact Group considered that it would be useful if the Governments of Germany, Kenya, Switzerland and Uruguay, as well as any other potential host Government, would provide to the interim secretariat, by 30 September 1994, financial and physical details of their offer, in order for the secretariat, on the basis of the information thus received, to compile it in a comparative manner and submit it to the Contact Group, which would forward its views to the Committee. This compilation would also be communicated to member States."

2. The Contact Group, before reaching this conclusion, had met with the representatives of the Governments in question during the tenth session. At that time it was agreed that a

questionnaire would be drafted by the secretariat to which the potential host Governments would provide answers (see annex I).

3. Details of the offers from the Governments of Germany, Switzerland and Uruguay were received by the secretariat in writing by 30 September 1994. On 18 November 1994 an offer to host the permanent secretariat was submitted by the Government of Canada; this offer was accompanied by detailed information.

4. On 18 November 1994, the Contact Group met in Geneva and considered, inter alia, the question of the physical location of the permanent secretariat. It held a meeting with representatives of the Governments of Canada, Germany, Switzerland and Uruguay. At that meeting, a comparison of the information provided by the four Governments was reviewed and supplementary information was made available by them. It was agreed that a summary of the four submissions would be presented in a comparative table prepared by the interim secretariat.

5. The comparative table is contained in annex II to the present note. The information therein is presented in accordance with indications given by the Governments in question. The complete texts of the offers received from these Governments are contained in document A/AC.237/Misc.45.

6. On 18 November 1994, the Contact Group also held a separate meeting with representatives of the Government of Kenya, who informed the Contact Group that the details of that Government's offer were being considered at the highest level of government. Any details that may be received by the secretariat to accompany the offer of the Government of Kenya will be issued in an Addendum to document A/AC.237/Misc.45. A summary of the information provided will be included in a revision of the comparative table.

- diplomatic representation of Governments
 - presence of international organizations
 - presence of national organizations relevant to the Convention
 - international transport and travel facilities
 - local mass transit facilities
 - international and local telecommunications facilities
 - local availability of trained personnel for possible employment in the permanent secretariat (language skills, electronic data processing and other office machine skills)
 - health facilities. Would access of delegates and staff to hospitals be possible?
 - availability of housing
 - availability of schooling
 - transfer of funds to and from foreign countries for the secretariat and for staff members.

Privileges and immunities of the staff of the secretariat

10. Please outline the privileges and immunities which would be conferred to the staff of the secretariat.
11. Please indicate if there would be restrictions on employment of dependents of staff members.

Other relevant information

12. You are welcome to provide any other information deemed relevant.
