Participants in the sixth session of the Intergovernmental Negotiating Committee for a Framework Convention on Climate Change were informed of the efforts of the interim secretariat, in collaboration with the UNEP/WMO Information Unit on Climate Change (IUCC), to build up a reference unit on climate change (A/AC.237/Misc.24). Listings of titles available in the bibliographical (CLIMA) and periodicals (CCPER) databases, as of 30 November 1992, were provided in that document.

Since that date, material available from the United Nations Institute for Training and Research (UNITAR) has been included in the computerized databases and figures in the attached listing of titles.

It is hoped that material available from the secretariat of the Intergovernmental Panel on Climate Change (IPCC) will also be included and that it will subsequently figure in the next listing of titles.

Since December 1992, the collection of material referenced in CLIMA and CCPER has expanded. Listings of additional titles, as of 15 July 1993, are contained in the present document for your information.

The reference unit is still managed on an ad hoc basis, without the expertise and competence of a documentalist. It is hoped that resources will soon be made available to permit the engagement of a documentalist to work jointly with IUCC and the interim secretariat. As part of the development of the secretariat's information system and data-processing capabilities, the databases will also be upgraded and improved, especially in terms of user-friendliness and accessibility (see A/AC.237/40, section IV.C).

The inclusion of a publication in this listing does not reflect any endorsement of that publication by the United Nations or any of its specialized agencies. Readers are welcome to reprint the contents of the listing for further distribution if the source of information is cited.
