## Tuesday, 28 March 1995

#### **PLENARY**

First meeting

#### Opening of the Conference [1]

The Executive Secretary opened the Conference.

#### Election of the President [2]

Her Excellency Mrs. Angela Merkel, Federal Minister for the Environment, Nature Conservation and Nuclear Safety of the Federal Republic of Germany, was elected, by acclamation, President of the Conference.

The President of the Conference made a statement.

#### Statements [3]

(a) Statements at the opening of the session

A message from the Secretary-General of the United Nations was conveyed to the Conference.

The representative of the Philippines (on behalf of the Group of 77 and China) made a statement.

The Executive Director of the United Nations Environment Programme made a statement.

The Under-Secretary-General for Policy Coordination and Sustainable Development made a statement.

The Executive Secretary of the interim secretariat of the United Nations Framework Convention on Climate Change made a statement.

#### (a) Status of ratification of the Convention

#### (b) Adoption of the rules of procedure

Following a statement by the President, the Conference agreed to apply the draft rules of procedure contained in document A/AC.237/L.22/Rev.2, as amended in document FCCC/CP/1995/2, with the exception of rule 42.

The Conference agreed that the President continue negotiations on the rules of procedure and report thereon to the Conference at its meeting on Monday, 3 April.

The representative of the United States of America made a statement.

#### (c) Adoption of the agenda

The Conference adopted its agenda for the session as contained in document FCCC/CP/1995/1.

#### (d) Election of officers other than the President

The President made a statement of clarification in response to a question raised by the representative of Kuwait.

## (f) Organization of work, including the establishment of a Committee of the Whole

#### Establishment of a Committee of the Whole

The Conference decided to establish a Committee of the Whole and designated the Vice-President of the Conference, Mr. Raúl Estrada-Oyuela (Argentina), as its Chairman.

The Conference also decided to allocate to the Committee those agenda items on which consensus had not been reached or on which some work remained outstanding.

#### Schedule of meetings

The Conference approved its schedule of meetings as contained in annex II to document FCCC/CP/1995/3, on the understanding that the schedule of meetings of the Committee of the Whole would remain flexible.

#### Ministerial segment

The Conference decided to set a time-limit of <u>five minutes</u> in respect of statements at the ministerial segment.
