Note by the secretariat

1. The Conference of the Parties, at its second session, by its decision 10/CP.2, requested the Convention secretariat to make available to the Subsidiary Body for Implementation (SBI), at each of its sessions, details of the financial support made available to Parties not included in Annex I to the Convention by the Global Environment Facility (GEF), as an entity entrusted with the operation of the financial mechanism for the preparation of their initial communications, including projects in this regard proposed by each Party, the funding decisions and the date and amount of funds made available to the Party (FCCC/CP/1996/15/Add.1).
2. The attached table contains information obtained from the Secretariat of the Global Environment Facility (GEF).*
3. Parties may wish to note that the table includes a column entitled "Date of Project Document Signature". The secretariat has been informed by the GEF that project funds are available from the GEF Trust Fund to the Party concerned from the date a project document is signed by the Party and an Implementing Agency (United Nations Development Programme (UNDP), United Nations Environment Programme (UNEP), or the World Bank), and that project funds are disbursed by the Implementing Agency in conformity with disbursement arrangements

provided for in the project document. In response to views expressed by the Conference of the Parties that disbursements of funds should be expedited, the Chief Executive Officer (CEO) of the GEF agreed with the Implementing Agencies that all efforts would be made to accelerate the disbursement of funds and that 15 per cent of the GEF project would be made available to the recipient Party as soon as the project proposal is approved by the CEO.

4. Parties may further wish to note that, according to the GEF Secretariat, projects described in the attached table as being approved through expedited procedures, and all national level projects approved under standard procedures, as well as the Pacific Island Climate Change Assistance Project include assistance for the preparation of initial national communications. The remaining projects, that is, pilot phase projects and other regional or global projects approved under standard procedures, cover assistance for the preparation of elements of the initial national communication, and not the communication itself.
