1. Welcoming ceremony of the high-level segment of the seventh session of the Conference of the Parties

The high-level segment of the seventh session of the Conference of the Parties will start promptly at 10.00 a.m. to hear statements by United Nations bodies and specialized agencies. Following the statements, there will be a short break to prepare for the welcoming ceremony of the high-level segment. Participants are encouraged to remain in the room during this break.

His Royal Highness Prince Moulay Rachid of the Kingdom of Morocco will address the delegates and present a statement on behalf of His Majesty King Mohammed VI. The welcoming ceremony will start promptly at 11.30 a.m. Participants are asked to take their seats by 11.15 a.m. The ceremony may also be followed on the CCTV monitors.

In addition to seats for invited guests, delegations have received entry passes to ensure that at least two seats will be available per delegation on the lower level of the Salle des Ministres. A number of additional seats will also be available on a first come, first served basis on the middle level. The upper balcony is reserved for non-governmental organizations and members of the press.

The doors of the plenary will be closed at 11.20 a.m.

Those Parties that were not given their passes for the high-level segment at the third plenary meeting are kindly requested to come to the Information desk before the start of today's plenary meeting.

Delegates are reminded that statements during the high-level segment should not exceed the three- to four-minute limit, as decided by the Conference of the Parties at its first plenary meeting. Parties are encouraged to consider consolidating individual statements into one statement made on behalf of a group of Parties, in which case a time limit of five minutes will apply. Given the large number of statements, we kindly suggest that statements be as brief and concise as possible, with full texts available for distribution (see below for the quantities required). If Parties do not wish to speak but would prefer only to have their statements circulated, the secretariat will make arrangements to distribute the copies and enter the statement in the records of the Conference.

Any changes in the name and rank of the speaker previously communicated to the secretariat should be provided as early as possible so that the speaker's list can be corrected accordingly. Contact persons are Mr. Horacio Peluffo or Ms Carrie Aßheuer in Salle Royale (Plenary 1).

Parties are kindly requested to note that the secretariat is not in a position to accommodate individual requests for changes in a Party's speaking slot. Parties wishing to make a change should arrange to exchange slots with another Party, and jointly notify the secretariat of the agreement that has been reached.

All Parties are kindly requested to provide the Conference Officer with 20 copies of their statements in advance to meet the needs of the interpreters and the Conference records. Parties wishing to have their statements distributed during the plenary meeting are requested to provide 300 copies. These copies may be delivered to the Conference Officer's table.
