I. INTRODUCTION

- 1. The second part of the thirteenth session of the Subsidiary Body for Implementation (SBI) was held at the Netherlands Congress Centre, The Hague, Netherlands, from 13 to 18 November 2000.
- 2. At the opening meeting, held jointly with the Subsidiary Body for Scientific and Technological Advice (SBSTA) on 13 November 2000, the chairmen of the subsidiary bodies welcomed all Parties and observers to the second part of the thirteenth sessions of the subsidiary bodies.
- 3. The chairmen recalled that they had prepared new documents on some issues, following the mandates given by Parties at the first part of the sessions to facilitate and advance negotiations at the resumed sessions. In preparing these texts, the chairmen had drawn on views expressed at the first part of the thirteenth sessions, submissions from Parties, and extensive bilateral consultations, including inter-sessional consultations.
- 4. The chairmen expressed the hope that these revised texts would be useful additions to those considered at the first part of the sessions, all of which would remain on the table. They emphasized that solid, well-drafted decisions must be developed to lay the foundation for success at the sixth session of the Conference of the Parties (COP) and to make ratification of the Kyoto Protocol possible.
- 5. Also at the joint meeting on 13 November, the chairmen recalled that at the first part of the thirteenth sessions, they had requested the co-chairs of the contact groups to resume their responsibilities at the second part of the thirteenth sessions, including those who were not able to participate in the first part of the sessions (FCCC/SBI/2000/10, para. 71).

II. ORGANIZATIONAL MATTERS

(Agenda item 2)

- 6. The SBI considered this item at its 7th meeting, on 13 November. The Chairman recalled that at its 1st meeting, on 11 September, the SBI had adopted the agenda for the thirteenth session (FCCC/SBI/2000/10, para. 6). No new annotations had been prepared but a list of documents could be found in document FCCC/CP/2000/1/Add.2.
- 7. The Chairman recalled that at the first part of its thirteenth session, the SBI had concluded consideration of the following agenda items:
 - 11. Financial mechanism:
 - (a) Support to the Intergovernmental Panel on Climate Change;
 - 12. Venue of the seventh session of the Conference of the Parties.

III. IMPLEMENTATION OF ARTICLE 4.8 AND 4.9 OF THE CONVENTION (DECISION 3/CP.3 AND ARTICLES 2.3 AND 3.14 OF THE KYOTO PROTOCOL)

(Agenda item 3)

MATTERS RELATING TO ARTICLE 3.14 OF THE KYOTO PROTOCOL

(Agenda item 4)

1. Proceedings

- 8. The SBI considered these items together at its 6th and 8th meetings, held jointly with the SBSTA, on 13 and 18 November respectively. It had before it documents FCCC/SBI/2000/10/Add.1, FCCC/SB/2000/12, and conference room paper FCCC/SB/2000/CRP.18.
- 9. Statements were made by 11 Parties, including one speaking on behalf of the group of least developed countries, one speaking on behalf of the European Community and its member States, and one speaking on behalf of the Group of 77 and China.
- 10. At the 6th meeting, Mr. Bo Kjellén (Sweden) reported on the informal consultations relating to these items which had been held in Geneva, Switzerland, from 19 to 21 October.
- 11. Also at the 6th meeting, a representative speaking on behalf of the group of least developed countries, reported on the workshop for least developed countries, held in Geneva, Switzerland, from 16 to 17 October, to enable them to discuss their specific situations, needs and concerns related to adaptation, capacity-building and development and transfer of technologies.
- 12. At the same meeting, the chairmen of the subsidiary bodies referred discussion of this item to the contact group established at the first part of the session, under the co-chairmanship of Mr. Kjellén and Mr. Mohammad Reza Salamat (Islamic Republic of Iran). The chairmen thanked Mr. Abdulmuhsen Al-Sunaid (Saudi Arabia), who had co-chaired this contact group at the first part of the session in the absence of Mr. Salamat (FCCC/SBI/2000/10, para.11).

2. Conclusions

13. At their joint meeting on 18 November, having considered a proposal by the chairmen, the SBI and the SBSTA agreed to forward the text contained in conference room paper FCCC/SB/2000/CRP.18 for further consideration by the COP at its sixth session.

IV. PROCEDURES AND MECHANISMS RELATING TO COMPLIANCE UNDER THE KYOTO PROTOCOL

(Agenda item 5)

1. Proceedings

14. The SBI considered this item at its 6th and 8th meetings, held jointly with the SBSTA, on 13 and 18 November respectively. It had before it documents FCCC/SBI/2000/10/Add.2 and FCCC/SB/2000/11, and conference room papers FCCC/SB/2000/CRP.15/Rev.1 and Rev.2.

- 15. Statements were made by three Parties, including one speaking on behalf of the European Community and its member States, and one speaking on behalf of the Group of 77 and China.
- 16. At the 6th meeting, the co-chairmen of the Joint Working Group on Compliance (JWG) established by decision 8/CP.4, reported on the informal consultations relating to this item which had been held in New Delhi, India, from 12 to 14 October. At the same meeting, the chairmen referred discussion of this item to the JWG under the co-chairmanship of Mr. Harald Dovland (Norway), Chairman of the SBSTA, and Mr. Tuiloma Neroni Slade (Samoa).

17. At the joint meeting on 18 November, the SBI and the SBSTA took note of the report of the JWG (see annex I below). Also at that joint meeting, having considered a proposal by the chairmen and taking into account the amendments proposed, the SBI and SBSTA agreed to forward the draft decisions, the text on procedures and mechanisms and the text on final clauses contained in conference room paper FCCC/SB/2000/CRP.15/Rev.2 to the Conference of the Parties at its sixth session for further consideration.

V. ACTIVITIES IMPLEMENTED JOINTLY UNDER THE PILOT PHASE

(Agenda item 6)

1. Proceedings

- 18. The SBSTA considered this item at its 6th and 8th meetings, held jointly with the SBI, on 13 and 18 November respectively. It had before it conference room paper FCCC/SB/2000/CRP.23.
- 19. At the 6th meeting, the chairmen recalled that at the first part of the sessions, it had been concluded that the consideration of the draft revised uniform reporting format would be referred to the fourteenth sessions of the subsidiary bodies (FCCC/SBSTA/2000/10, para. 20). At the same meeting, the chairmen invited Mr. Kok Kee Chow (Malaysia) to consult on a draft decision on activities implemented jointly under the pilot phase, for consideration by the COP at its sixth session.

2. Conclusions

20. At their joint meeting on 18 November, having considered a proposal by the chairmen, the subsidiary bodies agreed to forward the draft decision contained in FCCC/SB/2000/CRP.23 to the COP at its sixth session for further consideration.

VI. MECHANISMS PURSUANT TO ARTICLES 6, 12 AND 17 OF THE KYOTO PROTOCOL

(Agenda item 7)

1. Proceedings

- 21. The SBSTA considered this item at its 6^{th} and 8^{th} meetings, held jointly with the SBI, on 13 and 18 November respectively. It had before it documents FCCC/SBSTA/2000/10/Add.1 (parts I-IV), FCCC/SB/2000/10 and Add.1-4, and conference room papers FCCC/SB/2000/CRP.19, FCCC/SB/2000/CRP.20 and Add.1, FCCC/SB/2000/CRP.21 and FCCC/SB/2000/CRP.22.
- 22. Statements were made by representatives of seven Parties, including one speaking on behalf of the Group of 77 and China and one speaking on behalf of the Alliance of Small Island States.
- 23. At the 6th meeting, Mr. Kok Kee Chow (Malaysia) reported on the inter-sessional consultations he had chaired on this item, at the request of the chairmen of the subsidiary bodies. At the same meeting, the subsidiary bodies agreed to continue their consideration of this item by way of the joint contact group convened at the first part of their thirteenth sessions under the chairmanship of Mr. Chow (FCCC/SBI/2000/10, para. 22).

2. Conclusions

24. At their joint meeting on 18 November, having considered a proposal by the chairmen, the SBSTA and the SBI agreed to forward the draft decisions contained in conference room papers FCCC/SB/2000/CRP.19, FCCC/SB/2000/CRP.20 and Add.1, FCCC/SB/2000/CRP.21 and FCCC/SB/2000/CRP.22 to the COP at its sixth session for further consideration.

VII. CAPACITY-BUILDING

(Agenda item 8)

A. Capacity-building in developing countries (non-Annex I Parties)

(Agenda item 8 (a))

B. Capacity-building in countries with economies in transition

(Agenda item 8 (b))

- 25. The SBI considered these sub-items together at its 6th and 8th meetings, held jointly with the SBSTA, on 13 and 18 November respectively. It had before it documents FCCC/SBI/2000/10/Add.3 and FCCC/SBI/2000/10/Add.4, and conference room papers FCCC/SB/2000/CRP.16 and FCCC/SB/2000/CRP.17/Rev.1.
- 26. Statements were made by four Parties, including one speaking on behalf of the Group of 77 and China.

27. At the 6th meeting, the chairmen referred discussion of this item to the contact group established at the first part of the session, under the co-chairmanship of Mr. John Ashe (Antigua and Barbuda) and Mr. Jukka Uosukainen (Finland) (FCCC/SBI/2000/10, para. 26).

2. Conclusions

28. At their joint meeting on 18 November, having considered a proposal by the chairmen, the SBI and the SBSTA agreed to forward the draft decisions contained in conference room papers FCCC/SB/2000/CRP.16 and FCCC/SB/2000/CRP.17/Rev.1 for further consideration by the COP at its sixth session.

VIII. NATIONAL COMMUNICATIONS FROM PARTIES INCLUDED IN ANNEX I TO THE CONVENTION: GREENHOUSE GAS INVENTORY DATA FROM 1990 TO 1998

(Agenda item 9)

1. Proceedings

- 29. The SBI considered this item at its 7th and 9th meetings, on 13 and 18 November respectively. It had before it documents FCCC/SBI/2000/11 and Corr.1, FCCC/SBI/2000/14, FCCC/SBI/2000/INF.13 and FCCC/SBI/2000/INF.14, and conference room paper FCCC/SBI/2000/CRP.14.
- 30. Statements were made by three Parties. The representative of Argentina highlighted the importance of this discussion and stressed the need for Parties to give additional attention to the issue of the levels of GHG emissions from Annex I Parties.
- 31. At the 7th meeting, the Chairman noted that at its 3rd meeting, on 12 September, the SBI had agreed to consider a proposal by the Chairman for the conclusions on this item, at the second part of the thirteenth session (FCCC/SBI/2000/10, para. 30).

2. Conclusions

- 32. At its 9th meeting, on 18 November, having considered a proposal by the Chairman, the SBI adopted the following conclusions:
- (a) The SBI took note of the information contained in document FCCC/SBI/2000/INF.14 on the progress made with in-depth reviews of second national communications and requested the secretariat to prepare for the review of the third national communications due in November 2001;
- (b) The SBI took note of the information provided in document FCCC/SBI/2000/14 on the implementation of decision 6/CP.5² on the technical review of greenhouse gas (GHG) inventories from Parties included in Annex I and welcomed the publication on the web site of the secretariat of the status reports on greenhouse gas inventories from Annex I Parties. It requested

the secretariat to continue its activities in this area and noted the importance of the experience gained during the trial period in the use of the guidelines for the technical review of greenhouse gas inventories related to timing, level of effort and practical lessons learned, for possible further elaboration of the future greenhouse gas inventory review process under the Kyoto Protocol. The SBI also expressed its appreciation to those Annex I Parties volunteering for the review of their greenhouse gas inventories in the trial period;

- (c) The SBI took note of the documents prepared by the secretariat on national greenhouse gas inventory data from Annex I Parties (FCCC/SBI/2000/11 and Corr.1, FCCC/SBI/2000/INF.13). The SBI commended Annex I Parties for using the UNFCCC reporting guidelines on annual inventories, including the common reporting format, and noted with satisfaction the progress in the number of Annex I Parties reporting and in the timeliness of reporting. However, the SBI noted that some Annex I Parties have not fulfilled all aspects of the reporting requirements, specifically by either not providing a recent report, not reporting for all years, gases and sectors, or not fully completing the common reporting format. The SBI urged these Annex I Parties to make greater efforts to report in accordance with the UNFCCC reporting guidelines on annual inventories;
- (d) The SBI noted that, as a result of incomplete and inconsistent reporting by some Annex I Parties, it was difficult to compare trends in emissions. However, the SBI noted that, based on the reported data, Annex I Parties collectively had reduced their greenhouse gas emissions by 6 per cent in 1998 compared with 1990 levels, emissions from Annex I Parties with economies in transition having decreased by 37 per cent, while emissions from several Annex II Parties had increased, resulting in an overall increase in emissions from Annex II Parties of 7 per cent since 1990. The SBI expressed concern over the increase in emissions of many Annex I Parties and reaffirmed the need for further action to reverse the trend.

IX. NATIONAL COMMUNICATIONS FROM PARTIES NOT INCLUDED IN ANNEX I TO THE CONVENTION

(Agenda item 10)

A. Provision of financial and technical support

(Agenda item 10 (a))

- 33. The SBI considered this sub-item at its 7th and 9th meetings, on 13 and 18 November respectively. It had before it document FCCC/SBI/2000/INF.8 and conference room paper FCCC/SBI/2000/CRP.12.
- 34. A statement was made by one Party, speaking on behalf of the Group of 77 and China.
- 35. At the 7th meeting, the Chairman recalled that at the first part of the session the SBI had considered document FCCC/SBI/2000/INF.7. He further noted that the table on "Status of the preparation of national communications by Parties not included in Annex I to the Convention" would be posted on the UNFCCC web site and would be made available in hard copy on request

(FCCC/WEB/2000/2). The Chairman also recalled that by decision 12/CP.4 the secretariat was requested to compile and make available to the Parties a list of projects submitted by non-Annex I Parties in accordance with Article 12.4 of the Convention. He stated that, as of this year, the list of projects would be posted on the UNFCCC web site and be updated on a regular basis (FCCC/WEB/2000/1). This list of projects would be made available in hard copy on request.

36. Also at the 7th meeting, the Chairman noted that at its 3rd meeting, on 12 September, the SBI had agreed to consider a proposal by the Chairman for the conclusions on this item, at the second part of the thirteenth session (FCCC/SBI/2000/10, para. 35).

2. Conclusions

- 37. At its 9th meeting, on 18 November, having considered a proposal by the Chairman, the SBI adopted the following conclusions:
- (a) The SBI took note of the report of the secretariat on its activities to facilitate the provision of financial and technical support, and information on communications from Parties not included in Annex I to the Convention (non-Annex I Parties) (FCCC/SBI/2000/INF.7). The SBI also noted the technical needs, concerns and problems reported by those non-Annex I Parties that are still in the process of preparing their initial national communications, in particular the limited capacity for the completion of technical studies to be included in the national communications;
- (b) The SBI further noted the progress made by non-Annex I Parties in the preparation of their national communications (FCCC/WEB/2000/1);
- (c) The SBI noted with appreciation the information provided by the operating entity of the financial mechanism, the Global Environment Facility (GEF), regarding the details of its financial support, namely the dates of disbursement of funds for enabling activity projects for the preparation of initial national communications by non-Annex I Parties (FCCC/SBI/2000/INF.8), and requested the GEF to continue providing information on the effective availability of funds for enabling activity projects;
- (d) The SBI also took note of the document containing the list of GHG abatement projects submitted by non-Annex I Parties for funding in accordance with Article 12.4 of the Convention (FCCC/WEB/2000/2), and recommended that these projects should be brought to the attention of the GEF and, as appropriate, other bilateral and multilateral financing institutions, through the established channels.

B. Report of the second meeting of the Consultative Group of Experts (Agenda item 10 (b))

1. Proceedings

38. The SBI considered this sub-item at its 7th and 9th meetings, on 13 and 18 November respectively. It had before it documents FCCC/SBI/2000/16, FCCC/SBI/2000/INF.9, and FCC/SBI/2000/INF.10, and conference room paper FCCC/SBI/2000/CRP.13/Rev.1.

- 39. At the 7th meeting, the Chairman noted that at its 3rd meeting, on 12 September, the SBI had agreed to consider this sub-item at the second part of the session (FCCC/SBI/2000/10, para. 36).
- 40. Also at the 7th meeting, at the invitation of the Chairman, the Chairman of the Consultative Group of Experts on National Communications from Parties not included in Annex I to the Convention (CGE), Mr. Ayite-lo Ajavon (Togo), provided the SBI with an oral report on the Group's second meeting, which was held in The Hague from 9 to 10 November 2000. The Chairman of the SBI noted that the written report will be made available at the fourteenth session of the SBI.
- 41. Statements were made by three Parties.

- 42. At its 9th meeting, on 18 November, having considered a proposal by the Chairman, the SBI adopted the following conclusions:
- (a) The SBI took note of the report of the first meeting of the Consultative Group of Experts, held in Bonn, Germany on 8 and 9 June 2000 (FCCC/SBI/2000/16);
- (b) The SBI further took note of the reports of the two regional workshops organized by the secretariat, one for the African region, held in Nairobi, Kenya, from 15 to 18 August 2000 (FCCC/SBI/2000/INF.9), and one for the Asian region, held in Bangkok, Thailand, from 16 to 20 October 2000 (FCCC/SBI/2000/INF.10), and noted that the CGE had been successful in conducting the three regional workshops scheduled for the year 2000;
- (c) The SBI, noting with appreciation the oral report of the Chairman of the CGE on the progress of work in the implementation of the Group's mandate as contained in decision 8/CP.5, took note of the significant progress made and commended the Group for the work done so far:
- (d) The SBI urged Annex II Parties to provide adequate additional funding to support the work of the CGE in the next budget biennium;
- (e) The SBI further urged Annex II Parties to provide financial support to the CGE to enable it to complete its work in time for consideration by the SBI at its fifteenth session, so that a decision could be taken by the Conference of the Parties at its seventh session.

C. Second compilation and synthesis of initial national communications from Parties not included in Annex I to the Convention

(Agenda item 10 (c))

1. Proceedings

43. The SBI considered this sub-item at its 7th and 9th meetings, on 13 and 18 November respectively. It had before it the following documents: FCCC/SBI/2000/15 and FCCC/SBI/2000/L.5.

- 44. At the 7th meeting, the Chairman noted that at its 3rd meeting, on 12 September, the SBI had agreed to consider this sub-item at the second part of the session (FCCC/SBI/2000/10, para. 37).
- 45. Statements were made by four Parties.

46. At its 9th meeting, on 18 November, having considered a proposal by the Chairman, the SBI agreed to recommend a draft decision for adoption by the COP at its sixth session on the second compilation and synthesis of initial national communications from Parties not included in Annex I to the Convention (FCCC/SBI/2000/L.5).

X. FINANCIAL MECHANISM

(Agenda item 11)

A. Report of the Global Environment Facility to the Conference of the Parties

(Agenda item 11 (b))

1. Proceedings

- 47. The SBI considered this sub-item at its 7th and 9th meetings, on 13 and 18 November respectively. It had before it document FCCC/CP/2000/3 and Add.1, and conference room paper FCCC/SBI/2000/CRP.15.
- 48. Statements were made by four Parties, including one speaking on behalf of the Group of 77 and China.
- 49. At the 7th meeting, the Chairman noted that at its 3rd meeting, on 12 September, the SBI had agreed to consider this sub-item at the second part of the session (FCCC/SBI/2000/10, para. 41). Also at the 7th meeting, two representatives of the secretariat of the Global Environment Facility presented document FCCC/CP/2000/3 and Add.1.

2. Conclusions

- 50. At its 9th meeting, on 18 November, having considered a proposal by the Chairman, the SBI adopted the following conclusions:
- (a) The SBI took note of the report of the Global Environment Facility to the Conference of the Parties (FCCC/CP/2000/3). This report includes information on how the GEF has applied the guidance and decisions of the Conference of the Parties in accordance with the memorandum of understanding between the Conference of the Parties and the GEF Council;
- (b) The SBI also took note of the report of the GEF on the review of its climate change enabling activities (FCCC/CP/2000/3/Add.1). The SBI noted that the GEF, in its reports to the COP at its fourth and fifth sessions had indicated that, in 1999, it would undertake an evaluation of enabling activities in the climate change area. Some Parties, however, noted that the Conference of the Parties has sole responsibility for reviewing those activities and that only a limited number of enabling activity projects were considered in the review;

- (c) Some Parties noted the need for greater clarity in the guidance the Conference of the Parties provides to the operating entity of the financial mechanism to support enabling activities, urged the GEF to develop a more strategic and long-term approach to funding of enabling activities and stressed that the approval process for enabling activity projects should be shortened and streamlined;
- (d) In addition, a few Parties urged the GEF to encourage greater collaboration amongst its implementing agencies.

B. Other matters

(Agenda item 11 (c))

1. Proceedings

- 51. The SBI considered this sub-item at its 7th and 9th meetings, on 13 and 18 November respectively. It had before it document FCCC/SBI/2000/10, and conference room paper FCCC/SBI/2000/CRP.16/Rev.1.
- 52. Statements were made by nine Parties, including one speaking on behalf of the African Group, one speaking on behalf of the European Community and its member States, one speaking on behalf of the Group of 77 and China, and one speaking on behalf of the Alliance of Small Island States.
- 53. At the 7th meeting, the Chairman noted that at its 4th meeting, on 15 September, the SBI had agreed to further consider this item at the second part of the session by way of a contact group co-chaired by himself and Mr. Kerry Groves (Australia) (FCCC/SBI/2000/10, para. 45).

2. Conclusions

54. At its 9th meeting, on 18 November, having considered a proposal by the Chairman, the SBI agreed to forward the draft decision contained in conference paper FCCC/SBI/2000/CRP.16.Rev.1, for further consideration by the COP at its sixth session.

XI. ADMINISTRATIVE AND FINANCIAL MATTERS

(Agenda item 13)

A. Possible options to respond to late payment of contributions

(Agenda item 13 (a))

- 55. The SBI considered this sub-item at its 7th meeting, on 13 November. It had before it document FCCC/SBI/2000/10.
- 56. The Chairman recalled that at its 3rd meeting, on 12 September, the SBI had decided to postpone its consideration of the draft decision (FCCC/SBI/2000/10, annex II) until the second part of the session (FCCC/SBI/2000/10, para. 55). He informed the SBI that several delegations wished to postpone this item until the fourteenth session owing to the heavy workload on issues that must be given priority at the current session.

57. At its 7th meeting, on 13 November, the SBI agreed to postpone further the consideration of this sub-item until its fourteenth session.

B. Interim financial performance 2000

(Agenda item 13 (c))

1. Proceedings

- 58. The SBI considered this sub-item at its 7th meeting, on 13 November. It had before it document FCCC/SBI/2000/INF.11 on the status of contributions as at 31 October 2000.
- 59. A statement was made by one Party.

2. Conclusions

60. After recalling that the work under this item had been finalized at the first part of its thirteenth session and that draft decisions for consideration by the Conference of the Parties at its sixth session had been included in document FCCC/CP/2000/1/Add.1, the SBI took note of the latest status of contributions as at 31 October 2000.

C. Implementation of the Headquarters Agreement

(Agenda item 13 (d))

- 61. The SBI considered this sub-item at its 9th meeting, on 18 November 2000. The representative of Germany reported that the Government had agreed to offer joint accommodation for the secretariats of UNFCCC and the United Nations Convention to Combat Desertification (UNCCD) in the former parliamentary area. This would be available by the end of 2002. He confirmed that the conference facilities in the immediate vicinity of the premises would be made available for use by UNFCCC.
- 62. The representative of Germany also updated the SBI on the situation regarding issuance of visas, residence status of the secretariat staff and exemption from work permit requirements for their dependants.
- 63. The Executive Secretary, in response, confirmed receipt of a letter from the Federal Minister for the Environment, Nature Conservation and Nuclear Safety and the Federal Minister for Economic Cooperation and Development addressed to him and the Executive Secretary of UNCCD, offering the new office accommodation. He thanked the Government for the offer, and said that both executive secretaries would respond to the letter once the proposed accommodation had been evaluated. He welcomed the co-location with UNCCD and looked forward to the establishment of a new "United Nations House".
- 64. On the issuance of visas, residence status and work permits, the Executive Secretary expressed his hope that the host authorities would continue to review the needs and find ways of improving the process.

65. At its 9th meeting, on 18 November, the SBI took note of the statements made by the host Government and the Executive Secretary. The SBI thanked the host Government for its efforts to provide suitable accommodation to the Convention secretariat, and invited the Government and the Executive Secretary to report on progress made on this issue at its next session. Meanwhile, the SBI invited the Government of Germany to continue its efforts to improve the process of issuing visas to delegates as well as entry and residence visas and work permits to the dependants of secretariat staff.

D. Programme budget for the biennium 2002-2003

1. Proceedings

66. At its 7th meeting, on 13 November, the SBI recalled its intention to start discussions on the programme budget for 2002-2003 at the resumed thirteenth session (FCCC/SBI/2000/10, para. 58). The Chairman held informal consultations with interested Parties.

2. Conclusions

67. At its 9th meeting, on 18 November, the SBI agreed to consider this sub-item at its fourteenth session, with a view to recommending to the COP a draft programme budget for the biennium 2002-2003 for adoption at its seventh session.

XII. OTHER MATTERS

(Agenda item 14)

68. At the 7th meeting, on 13 November, the Chairman noted that at its 3rd meeting, on 12 September, the SBI had agreed to consider issues related to Articles 7 and 8 of the Kyoto Protocol at the second part of its thirteenth session after the SBSTA had arrived at conclusions on the guidelines on those articles, with the aim of submitting those guidelines for adoption by the Conference of the Parties at its sixth session (FCCC/SBI/2000/10, para. 64).

2. Conclusions

69. At its 9th meeting, on 18 November, the SBI endorsed forwarding draft guidelines for the preparation of the information required under Article 7 of the Kyoto Protocol and draft guidelines for the review under Article 8 and their corresponding draft decisions contained in conference room paper FCCC/SBSTA/2000/CRP.17 to the COP for further elaboration.

XIII. REPORT ON THE SESSION

(Agenda item 15)

1. Proceedings

70. At its 9th meeting, on 18 November, the SBI considered the draft report on the second part of its thirteenth session contained in conference rom paper FCCC/SBI/2000/CRP.11. At the same meeting, on a proposal by the Chairman, the SBI authorized the Rapporteur, with the

assistance of the secretariat, to complete the report of the session, under the guidance of the Chairman.

XIV. CLOSURE OF THE SESSION

71. At the final joint meeting of the SBI and the SBSTA, on 18 November, the chairmen recalled that during the thirteenth sessions of the subsidiary bodies, Parties had been able to advance understanding, start to reconcile interests and narrow down the options. They also noted that much work remained to be done by ministers and their representatives in order to work out the outstanding issues.

Annex I

REPORT OF THE JOINT WORKING GROUP ON COMPLIANCE ON ITS WORK DURING THE SECOND PART OF THE THIRTEENTH SESSIONS OF THE SUBSIDIARY BODIES

I. INTRODUCTION

- 1. The meetings of the Joint Working Group on Compliance (JWG) were presided over by the Co-Chairmen, Mr. Harald Dovland (Norway) and Mr. Tuiloma Neroni Slade (Samoa).
- 2. The Co-Chairmen opened the meetings of the JWG on 14 November 2000. They recalled that the JWG had requested them to further develop the text on procedures and mechanisms on compliance. In order to fulfil their mandate, the Co-Chairmen had drawn on the discussions at the first part of the thirteenth sessions as well as at informal consultations held from 12 to 14 October 2000 in New Delhi, India. Based on those discussions, the Co-Chairmen had prepared the text on compliance contained in document FCCC/SB/2000/11.

II. PROCEDURES AND MECHANISMS RELATING TO COMPLIANCE UNDER THE KYOTO PROTOCOL

1. Proceedings

3. The JWG held four meetings from 14 to 17 November. Statements were made by the representatives of 20 Parties, including one speaking on behalf of the Group of 77 and China, one speaking on behalf of the European Community and its member States and one speaking on behalf of the Alliance of Small Island States.

2. Conclusions

4. The JWG, on the basis of a proposal by the Co-Chairmen, recommended for consideration by the Conference of the Parties at its sixth session, the draft decisions, the text on procedures and mechanisms, and the text on final clauses contained in conference room paper FCCC/SB/2000/CRP.15/Rev.1.

III. REPORT ON THE MEETINGS

5. The JWG considered and adopted the report on its meetings prepared by the Co-Chairmen.
