Corrigendum¹

Pages 10 and 11, paragraph 9:

Insert square brackets around the entire paragraph 9.

Page 10, paragraph 9, Option 2, line 2:

Replace the words *should consist* with *shall constitute*.

Page 11, paragraph 9:

Insert square brackets around subparagraphs (c) and (d), and (f) and (g).²

Page 11, paragraph 9:

Insert square brackets around subparagraph (e).³

Page 11, paragraph 10:⁴

Page 13, paragraph 6, line 3:

Delete *may*.

Page 17, heading of section J, paragraph 17, line 1, and paragraph 17 (a), line 1:

Insert square brackets around *and regional*.

¹ Please note that footnotes in this corrigendum were provided as explanatory text.

² Some Parties proposed subparagraphs (f) and (g) as alternatives to subparagraphs (c) and (d). This suggestion received broad acceptance by Parties, but due to lack of time the final text was not agreed upon.

³ This subparagraph was provided by a group of Parties, but due to lack of time the final text was not agreed upon. In document FCCC/SBSTA/2000/13 a similar paragraph was in square brackets.

⁴ Some Parties suggested that paragraph 10 should be moved to the COP decision (see page 6, paragraph 4).

Page 25, section E:

Insert square brackets around the entire section.⁵

Page 33, paragraph 29:

Merge subparagraphs (a) and (b) to read as follows:

(a) Experts must successfully undergo an assessment of their competence in their respective fields taking into account that complementary training is offered to nominated experts to enable them to qualify for participation in the review process and carry out specific tasks;

Page 34, paragraph 35, line 2:

Replace *should* by *shall*.

DHG.00-156 **aph 75, subparagraph (c):**

Subparagraph (viii bis) as follows:

[(viii bis) Recurrence of adjustments as identified under paragraph 62 above;]

Page 51, paragraph 108⁶
