#### ROSTER OF EXPERTS TO PARTICIPATE IN IN-DEPTH REVIEWS

#### Note by the secretariat

- 1. The secretariat has concluded reviews of the second national communications of Parties included in Annex I to the Convention. It is assumed that in-depth reviews of the third national communications, which according to decision 11/CP.4, are due by 30 November 2001, will start in 2002. In accordance with decision 9/CP.2, the reviews will be carried out by teams coordinated by the secretariat (see FCCC/CP/1996/15/Add.1).
- 2. Experts participating in the in-depth reviews should be nominated by Parties and intergovernmental organizations. The roster of experts was last updated in 1998 and many experts nominated by their respective governments may have changed their position since then. Updating of the roster in 2001 would enable the secretariat to be better prepared for the review of the third national communications.
- 3. Parties are invited to nominate experts for the roster. Parties and international organizations are kindly reminded that nominations should be submitted to the secretariat through the official channels of communication and using the attached nomination form (see annex below). The completed nomination form, giving information on area of expertise and language proficiency, as well as a detailed curriculum vitae, is essential to the selection process. The experts nominated are encouraged to be as specific as possible, when defining their areas of expertise. This will enable the secretariat to ensure an equitable distribution of skills and

knowledge as well as geographical balance in the review teams, and will also contribute to the proper conduct of the reviews.
