ADMISSION OF ORGANIZATIONS AS OBSERVERS

Admission of observers: intergovernmental and non-governmental organizations

Note by the secretariat*

- 1. The admission of intergovernmental and non-governmental organizations as observers at sessions of the Conference of the Parties is governed by Article 7, paragraph 6, of the Convention, which provides, inter alia, that "[a]ny body or agency, whether national or international, governmental or non-governmental, which is qualified in matters covered by the Convention, and which has informed the secretariat of its wish to be represented at a session of the Conference of the Parties as an observer, may be so admitted unless at least one third of the Parties present object".
- 2. At its first session, the Conference of the Parties agreed that the secretariat should invite to future sessions of the Conference of the Parties, and of its subsidiary bodies, all intergovernmental and non-governmental organizations admitted at that session and at future sessions, unless an objection was raised to any particular organization in accordance with the Convention and the rules of procedure (FCCC/CP/1995/7, para. 22). Consequently, all the organizations admitted to previous sessions of the Conference of the Parties (with the exception of those which were admitted for a single session only) have been invited to attend the eighth session, and only new applicants need to undergo the procedure for admission to the Conference of the Parties.
- 3. The secretariat has prepared a list of new applicant intergovernmental and non-governmental organizations that have expressed a wish to be admitted to the eighth session of the Conference of the Parties, for consideration by the Parties at the start of the session.

- 4. In drawing up the list, the secretariat has taken due account of the provisions of Article 7, paragraph 6, of the Convention and of the established practice whereby non-governmental organizations are required to furnish proof of their non-profit and/or tax-exempt status in a State Member of the United Nations, of one of its specialized agencies or of the International Atomic Energy Agency, or in a State Party to the International Court of Justice.
- 5. The Bureau of the Conference of the Parties has considered the list of applicants (see annex to this document) and has raised no objections to the organizations listed. These organizations have been advised of their "pre-admittance status" on the understanding that the final authority for their admission as observers rests with the Conference of the Parties.
- 6. The Conference of the Parties is invited, at its first plenary meeting, to accord observer status to the intergovernmental and non-governmental organizations listed in the annex.
