Status of the preparation of national communications from Parties not included in Annex I to the Convention

Note by the secretariat

I. MANDATE

1. By its decision 10.CP/2, the Conference of the Parties requested the secretariat, inter alia, to facilitate assistance to Parties, particularly developing country Parties, in the preparation of their national communications and to provide to the Subsidiary Body for Implementation and the Subsidiary Body for Scientific and Technological Advice at each of their sessions a report on how it is facilitating such assistance (FCCC/CP/1996/15/Add.1).

II. APPROACH

- 2. In response to the above mandate, the secretariat provides two reports to the subsidiary bodies. The first one, as contained in document FCCC/SBI/2002/INF.11, describes the activities of the secretariat to facilitate the provision of financial and technical support for the preparation of national communications from Parties not included in Annex I to the Convention (non-Annex I Parties) and also includes information on those communications. The second report, as contained in the present document, includes a table on the status of preparation of national communications from non-Annex I Parties.
- 3. The table is prepared using information obtained from: (i) replies received from non-Annex I Parties during the period February to May 2002 to a questionnaire on the status of preparation of their national communications; (ii) national responses from Parties to a questionnaire distributed by the UNFCCC secretariat during the year 2001; and (iii) the Global Environment Facility (GEF) and its implementing agencies. An updated version of this table is presented to the subsidiary bodies at each of their sessions. The document is posted on the secretariat's web site (unfccc.int/resource/webdocs/2002/09.pdf); hard copies are available on request.
